## **Revive Camps Registration & Deadline Policy**

At Revive Camps, we are excited to see how God is using this ministry to impact more lives for Christ each year. As our camps continue to grow, so does the need for a more structured registration process. To ensure the best experience for every camper, we have established clear deadlines and policies for registration, payments, and cancellations.

### **Why These Deadlines Matter**

Organizing a camp experience for hundreds of children and youth requires careful planning. Everything from lodging and meals to staffing and activities depends on knowing how many campers and adults will be attending. By following these deadlines, you help us provide a high-quality, Christ-Centered camp experience for everyone.

### **Our Limited Staffing Before Camp**

As much as we Love Revive, our leadership team serves in this ministry while also holding full-time ministry jobs. In the months leading up to camp, we operate with a small staff, making it difficult to process last-minute changes or exceptions. Please help us by honoring deadlines, submitting accurate information, and finalizing payments on time. Your cooperation allows us to focus on creating an incredible camp experience for every child and student.

### **Key Registration Information**

Winter Group Registration Opens - **September 1**  
*(\$50 Deposit Required to secure spots.)*

When you process a group registration, you are required to indicate that at least two (2) adults will be attending with you to camp. Revive Camps have minimal paid staff, and thrive mostly on volunteers. We are a Church Group camp, meaning we rely on adults from your churches to help chaperone the kids during the week. If you have a smaller church that does not have enough volunteer support, let us help you get connected to another church nearby. Deposits are **non-refundable** but transferable in the same group and in the same camp you are attending.

## Late Registration Begins - **January 1** (For All Summer Camps)

After the May 1 Deadline, the cost will increase by \$25. Late Registrations are accepted as space allows but are not guaranteed. This means if you have pre-registered for spots as a group, your unused spots are not guaranteed after May 1. This is to encourage earlier registrations.

### Late Drop Fee - **25% Per Dropped Spot**

If a registered camper cancels within two weeks of camp, a 25% "Empty Pillow Fee" will be charged per spot. This policy ensures we cover our commitments already made for lodging and to cover administrative costs of making the changes. This will also be assessed on a Case-by-case basis for emergencies.

### **How to Plan Ahead**

To avoid late fees or last-minute issues, we encourage groups to:

- Register Your Groups Early to secure Spots
- Confirm numbers well before the deadline. Set your own local deadline at least a week before the Revive Deadline.
- Communicate any changes as soon as possible.

We understand that unexpected situations arise, and we will always strive to work with you. However, honoring these deadlines helps us to steward resources wisely and create an amazing camp experience for everyone.
